Greetings to Friends and Supporters,

I am excited to share some wonderful things that are happening here at The Center for Family Justice, while remaining laser-focused on our mission to provide life-saving services to all those impacted by domestic abuse, sexual violence and child abuse.

We saw a 32 percent increase in services provided to clients over the previous year. We served more than 5,500 people. We continue to see the consequences of abuse in families and individuals, who often feel scared, isolated and shame.

But there is hope.

The State Bond Commission approved a \$1.2 million grant-in-aid to make much-needed renovations and improvements to our main building so we can only enhance our programs and services in an even more safe and secure environment.

We unveiled the name of our new safe house, "Patti's Place," in honor of our beloved volunteer, donor and friend Patti Masarek. This safe house, which we hope to open by the end of the year, will help us serve more families seeking immediate safety with their pets.

We are seeing an increase in the number of people enrolling in programs offered by our Training Institute and Prevention and Education programs. We recently held a very successful training series, "Engaging Men in Prevention" in April, and we held a free webinar for parents helping children through trauma.

We are engaging in schools with students, staff and parents.

Services through our Training Institute and Prevention and Education programs have increased by an amazing 65 percent as we work to stop the cycle of abuse in our families and inform members of the community who want to help!

We hosted amazing and inspirational people – author Rachel Louise Snyder at Speaking of Women in September and motivational speaker Emeka Nnaka at our Speaking with Men breakfast in November. We took time to remember the lives of the 32 victims lost last year at a beautiful multi-town vigil we had this past October at the Hartford Healthcare Amphitheater.

We honored 10 "Hope Heroines," women in our communities who have improved lives through their work, at our first-ever 'Women Rock!' benefit concert, presented by our friend Rob Fried and Band Central.

As you read this report recounting the past year, you will be amazed by all that we have accomplished together!

Just know that your support, so vital to our operation, is seen, and we are very grateful.

PREVENTION AND EDUCATION PROGRAMS CONTINUE TO GROW



Fairfield Ludlow High School's leadership group Raising Abuse Awareness for Teens (RAAFT) Club visited CFJ in April 2022 when they came for a tour and to attend a workshop on healthy relationships and boundaries.

At The Center for Family Justice, our **Prevention and Education** program staff work hard to engage students K-12 and college with effective age-appropriate education and training focused on the prevention of intimate partner violence, sexual violence, child abuse and human sex trafficking to children, youth, parents, faculty, and staff.

We focus on several areas including body safety, consent, bullying prevention, conflict resolution, dating violence, sexual harassment, sexual violence and how we can mobilize bystanders to speak up and act when they see violence and abuse in their families, schools, campuses, workplaces, and neighborhoods.

Elizabeth M. Pfriem's Pathways to HOPE and Camp HOPE America-Bridgeport programs

Through our Elizabeth M. Pfriem's Pathways to HOPE and Camp HOPE America-Bridgeport programs, CFJ has increased its ability to support children and youth ages 7-17 impacted by abuse by providing year-long engagement and mentoring programs including overnight summer camp.

"If you can't be safe in your own home, then where can you be?"

This is the question posed to visitors to the EmpowerHouseProject. org website, a page set up to inform the public about this vital work to build another safe house for our clients seeking shelter from immediate, life-threatening situations.

No one is more passionate about making this project come to fruition than Patti Masarek, who co-chairs The Empower House project along with her husband Alan.

With her compassionate and friendly approach to everything she does, Patti was the perfect name to adorn this safe house, so we at The Center for Family Justice proudly announced that The Empower House will now be known as Patti's Place.

When she isn't busy helping us raise funds for our programs or co-chairing our Speaking of Women event in September, Patti can be found playing with the children whose parents attend support groups here at the center.

Patti's husband Alan also showed his dedication to the project with his months-long cross-country Empower Ride, which raised vital funding.

Patti and Alan remain as committed as ever as we move toward the building's completion, and as we raise funds to keep the building running after it opens.

Patti's Place will be a state-of-the-art facility that will be secure for individuals and families and will include a kennel for pets. The building will also house vital services including free legal support, wellness, social counseling, housing and job-seeking assistance.


We expect the safe house to open its doors by the end of the 2023 calendar year.

PROVEN BY NUMBERS: CFJ HAS A SIGNIFICANT IMPACT

You often see and hear us talk about the impact we have on our clients' lives through interviews in the media, during speeches before community groups and through our social media posts and reports like this one.

We often talk about our services being geared toward helping people become self-sufficient as they leave the abuse behind. But we are sure you have often wondered how exactly the client thinks. What do the people who receive our services feel about the way The Center for Family Justice handles their cases?

We wondered the same thing, so in 2022 we initiated a survey that would help us evaluate what the client has to say about what we do.

More than 90 percent of clients who participated in the evaluation said they would return to CFJ, while 91 percent said they would recommend our services to someone else.

More importantly, 92 percent of clients feel CFJ is supportive of them making their own decisions, and 91 percent feel confident that CFJ is here to help them on their journey.

People who come to The Center for Family Justice are doing so because they are in fear of their personal safety.

Leaving an abusive situation means survivors must start over, with little in terms of money, or a safe place to live. In some cases, they have been brought here from another country, which, for those whose first language is not English, can be another barrier to leaving the abuse.

We have helped people by providing them with free legal assistance in family court—an expense not many can afford. We have helped people take English-as-A-Second-Language classes to increase their ability to get a job. We have provided support groups and counseling services to those struggling with trauma.

We help children through our Camp HOPE-Bridgeport and Pathway to HOPE programs.

Michaela Zaffino – 2023's Beatrice Boucher Volunteer of the Year – considers her time as a domestic violence advocacy intern a privilege that allowed her the opportunity to meet clients from all walks of life.

CFJ staff describe Michaela as a hard worker who is a tireless advocate for her clients."When presented with an issue affecting one of her clients, Michaela worked

doggedly to find a solution, went out of her way to explain issues that were affecting her clients, came up with resources and solutions for every issue her clients had," wrote one colleague in her nomination. Michaela carried a caseload of clients, performed crisis intervention with walk-in clients and answered calls to the 24-hour crisis hotline.

Michaela recently completed a master's degree in social work from Southern Connecticut State University. She will move on to Wellmore Behavioral Health in Waterbury where she will work under its Child First program.

Michaela said she gained vital experience during her time at CFJ. "I was constantly reminded that domestic and sexual violence do not discriminate against any gender, race, or social class," Michaela explained. "I am so grateful that I was given the opportunity to help survivors during some of their most difficult days."

Whenever a department organizes an event or a photo at The Center for Family Justice, Silvia Paytas is the first one to gather folks and show up to support her colleagues. Silvia is the Bilingual Direct Services Intake Assistant at CFJ, and many who nominated Silvia noted her positive attitude.

A hard worker with a passion for CFJ's mission, Silvia also firmly established

herself as a team player, helping as a Spanish translator when needed and assisting with difficult cases. Silvia "shows empathy for her clients as they express their needs while in crisis," wrote one co-worker in her nomination. "She has knowledge and appreciation for the job, and it shows in her day-to-day work."

Silvia always makes a point of remembering staff birthdays, and usually is the first person to greet new employees and wish good luck to those moving on.

Silvia also created the Advocacy calendar, sending an email out to staff every month to get the latest information about events such as support groups and ESL classes. Her work on the calendar is just another example of how well Silvia collaborates with staff across all departments at CFJ.
